## From Secretary General's Desk...

Dear Colleagues,

First of all let me wish you all a very happy and prosperous New Year 2012.

As three billion more middle-class consumers join the global economy over the next two decades, the resource landscape will change profoundly: demand for many commodities will soar. The increasing demographic pressures on the natural resources, the imperative to maintain their sustainability, combined with the impending climate change poses new challenges that make the development processes more complex. These factors together with the potential environmental deterioration, itself driven by growing consumption of resources, could constrain growth and impact availability of some resources – water and food being the most obvious area of vulnerability.

Over the past 62 years, ICID has played a pivotal role in the untiring global efforts to eradicate hunger and poverty. It is a moot point of discussion whether the Malthusian specter would finally catch up or it would remain a hoax as proven time and again by the human ingenuity, developments in science and technology, and the resulting Green Revolution. ICID community has strongly contributed to the Green Revolution by successfully championing the cause of Irrigation, one of its three pillars, the others being the use of chemicals and developments in biotechnology. If Malthusian specter has to be kept at bay, another Green Revolution through technological and better socio-environmental interventions is called for. The second Green Revolution will have to be aimed at bridging the productivity gap, using water more efficiently and making



the green revolution more inclusive by covering all those countries that missed on the first Green Revolution, particularly from Africa. ICID will have to assume a leadership role in the process.

Inability of the irrigation sector to adequately deal with adverse environmental impacts and the limited success in furthering participatory irrigation management have made "irrigation" a seemingly unpopular word with in the development and environment circles. Irrigation is no more on the radar screen of the political agenda as apparent from the slow pace of investment in the sector during the past three decades. Flood management, although within the mandate of ICID and its NCs, has drawn less than adequate attention in the recent past.

During the last quarter of 2011, at the 21st Congress in Tehran in October and subsequently during the 2nd Arab Water Forum in Cairo in November, I had the privilege of interacting with the ICID community more closely. I listened carefully to the concerns and apprehensions of members. They range from frustration at the pace of reforms through which ICID is undergoing; to weak linkages with NCs that are the most vulnerable and need support; to the effectiveness of this wonderful network called ICID; and the lack of participation of many of the National Committees in the activities of the Commission. Exiguity of infusion of the young blood in the working of the organization is also a matter of grave concern, which in turn has also affected our capabilities to fully exploit the advances in information technology.

At the same time ICID is facing its own internal challenges: financial uncertainty has the most telling effect on its working. These

new and not so new challenges call for a change in the way we, the ICID fraternity, operate.

ICID needs to work closely with its partners on issues such as food and water security, water use efficiency, climate change adaptation, drought and flood management, agricultural and urban drainage, to name a few, where ICID and its National Committees have a crucial role to play. ICID has to take advantage of the presence of the National Committees at the country level, that helps implement new initiatives at the grass-root level. ICID will work together with its partners to walk the last mile and help them in meeting the shared objectives of poverty reduction through sustainable and green growth.

Let me assure you that the Central Office is geared to facilitate the efficient functioning of the network, to feel the pulse of the members and be the nucleus for change. As Theodore Roosevelt, 26th President of the United States once said: "In a moment of decision the best thing you can do is the right thing. The worst thing you can do is nothing." Accordingly, I will be coming to you often with new seeds of thought for your deliberations and decisions. Let me assure you that I will do my utmost to facilitate and accelerate this process of change further. With leaner Central Office a more informal but efficient and effective approach making use of the information technology is in the offing.

### ICID Invites Nominations for the WatSave Awards 2012

ICID instituted 'WatSave Awards' in 1997 to recognize 'outstanding, contribution to water saving / conservation in agriculture' annually, across the world. Entries for

the nominations for the 2012 awards are now open.

The aim of Annual Watsave Awards is to recognize the outstanding contributions to water conservation or water saving for the benefit of all the water-users. Accordingly, the Awards are only made in respect of actual realised savings and not for promising research results, plans and/or good ideas/intentions to save water.

The WatSave awards are given in four categories: (i) Technology; (ii) Innovative Water Management; (iii) Young Professionals; and (iv) Farmer.

The awards will be presented at the 63rd IEC meeting scheduled to be held during 24-30 June 2012 at Adelaide, Australia. The deadline for receipt of the entries from the National Committees along with a completed 'Nomination Form' etc. to the ICID Central Office, New Delhi is **30 March 2012**. The nominations sent directly to the Central Office, ICID can not be entertained.

Nominations are invited for the 'WatSave awards 2012' from individuals/team through National Committees/Committee. The entries are open to all professionals / teams from ICID member countries as well as non-member countries. In case of an entry from a 'non-member' country, the nomination has to be routed through and validated by an active National Committee of ICID, who should be in touch with the nominee and is aware of his / her work. The selection of the winners from amongst the nominations received will be made by an International Panel of Judges. ### International Workshop on 'Irrigation, Water Quality and Environmental Flows'

An International Workshop on 'Irrigation, Water Quality and Environmental Flows' is scheduled to be organized by ICID's

Working Groups on Environment (WG-ENV) and Working Group on Use of Poor Quality Water for Irrigation (WG-PQW) during 63rd International Executive Council (IEC) and 7th Asian Regional Conference (ARC) of ICID to be held during 24-30 June 2012 at Adelaide, Australia. The following subtopics will be dealt with under two main sub-themes:

#### Sub Topic Themes (Water Quality)

- Irrigation with poor quality water as a means to reduce environmental impacts (reduced salinity and plant nutrients)
- Health aspects associated with irrigation with poor quality water
- Environmental impacts associated with using poor quality water for irrigation
- Management practices that promote sustainable use of poor quality water for irrigation
- Institutional issues arising from poor water quality irrigation impacts on the environment
- Management of poor quality water to reduce salinization of water resources
- Management of poor quality water to reduce salinization of water resources.
- Management of poor quality water to reduce eutrophication (enrichment with plant nutrients) of water resources

#### Sub Topic Themes (Environmental Flows)

- Irrigation Return Flow: positive or negative externality? Experiences, case studies; quantitative and qualitative aspects, contribution to EFR
- Water quality of irrigation return flow: standards, regulations, monitoring systems
- Assessment of EFR: methodologies, experiences, case studies
- Impacts of implementing EFR on irrigation water use; techno-economic analyses
- Implementing EFR in context of offstream / in-stream multiple uses
- Case studies on EFR policy and implementation
- Ecosystem Services provided by irrigation drainage: case studies and experiences, policy mechanisms.

The Central Board of Irrigation and Power (CBIP) welcomed Mr. Tyagi and felicitated him on 5 January 2012. CBIP is an Indian institution, where the seeds of ICID were grown. CBIP was the key agency who organized ICID's annual meetings in New Delhi in 2009. Discussions were later held with Mr. Kanjlia, Secretary of CBIP on strengthening the bonds between CBIP and ICID and other related issues.

### Arab Water Forum

Second Arab Water Forum was organized by Arab Water Council in Cairo from 20-23 November 2011. A number of office bearers of ICID, including VP Dr Ragab Ragab; VPH Prof. Mohamed Hassan Amer, Chairman of the Egyptian National Committee on Irrigation and Drainage (ENCID); VPH Prof. Abu-Zeid, VPH Prof. Safwat Abdel-Dayem and VPH Dr. Hussein El-Atfy VPH and Secretary General (D) Mr. Avinash Tyagi, attended the Forum.



Out of 22 countries in the Arab region, 18 countries already suffer from water scarcity which is likely to be further deteriorated by 2050, due to population pressure and climate change. Agriculture sector that constitutes roughly 6.8% of GDP (although it reaches more than

30% in some countries) in the region continues to be a major component of the regional economy, providing jobs and food security. Arab countries continue to see agriculture as a sector with the potential for job creation.

The participants at the Forum called for greater investment in agriculture and make agriculture a strategic public policy priority by integrating the land and water strategies.

The participants gathered at the Forum called for policies that should reallocate subsidies to water saving crops and support water saving practices. The region also sees climate change with the consequent increased climate variability as a new and major challenge in its effort to ensure food and water security to its people. It sees the adverse consequences of climate change in the form of more frequent droughts.

The ICID office bearers present at the Forum strongly feel that ICID fraternity can play an active role by supporting the region in its efforts to develop resilience in the agriculture system against droughts through proactive actions. They call upon the ICID National Committees in the region to respond to the clarion call coming out of the Forum and draw up a regional response, closely working with the other partners from the region such as FAO and IFAD.
